7.New Business

FORM 700 Statement of Economic Interest- Lew reminded Board Members that they need to turn in their Form 700's by April 1st.

Request to schedule a Hearing for termination of sewer service at Dipsea Café.

Shonn informed Board about the lack of response from the Dipsea Café concerning installment of a grease interceptor. The Dipsea's owner was notified on October 21st 2019 to comply by December 31st 2019. Almonte has not received a response. This problem has been ongoing for years with several County Departments fully aware of the non-compliance. Almonte's County Counsel, Jack Govi, recommends a termination notice of sewer service and a Public Hearing to stop service. Jack will draft a letter to be mailed by certified mail and a copy to be placed on the Dipsea's door informing them of Public Hearing. Lew motioned to schedule Public Hearing of sewer service on February 24, 2020, Linda seconded. Approved 4-0. Board agreed if a signed contract was in place to install grease interceptor, and a paid deposit was put down for work, this would be enough paperwork to cancel Public Hearing.

8. Old Business:

2019 CIP Additions- Dave requested Board approve extra District line repair work on Julia Ave. Nute Engineering estimates the Julia cost between 65k and 70k. Dave presented Board with additional potential pipe segments that need repair, these could be added to the 2019 CIP. Glosage Engineering will honor the prices from 2019 CIP. Lew asked Dave to put together a CIP recommendation with three project costs, 100k, 250k and 500k. Board voted on project cost of Julia Ave extra pipe work to not exceed 70k. Anne motioned; Robert seconded. Approved 4-0.

Consideration of Sewer Service Rebate Program- Held over till next month.

Board Member Recruitment- Lew requested the wording from the previous ad placed in the IJ about acquiring a new Board Member sent to him to edit and review. Lew will also place an ad on Next Door.
